HIV IN TENNESSEE, BY THE NUMBERS:



16,190: the number of Tennesseans living with diagnosed HIV in 2016.



17th in the nation: in the number of new HIV diagnoses in 2017.



16th in the nation: in HIV prevalence numbers in 2016.



13th in the nation: in the number of HIV deaths in 2016.



- An estimated 12,834 Tennesseans received services through Ryan
- White in 2015.
- 61.6% were living at or below the poverty line.
- Since Ryan White is legally required to be the "payer of last resort,"
- these people did not have other access to medical or support
- services.



Tennessee received \$42.9 million in Ryan White funds in 2018

• \$14.04 million went to the AIDS Drug Assistance Program(ADAP).

RYAN WHITE IS CRUCIAL FOR TENNESSEE

- Over the past five years, annual funding decreased by 5%.
- The Ending HIV Epidemic: Plan for America would increase funding to Shelby County.



RYAN WHITE WORKS!



Ryan White services keep HIV-positive individuals in treatment and care



With treatment, people with HIV can live active, healthy lives.



People whose virus is suppressed for 6 months cannot transmit HIV through sex.





But, if disconnected from care, resistance to medications can develop making it easier to transmit HIV.

Moreover, without treatment HIV is deadly.⁴

While only 60% of people nationwide have a viral load that is effectively suppressed as of 2015, 5

of HIV-positive clients who had received at least one Ryan White funded medical care visit have achieved viral suppression.⁶

WITHOUT MEDICAID EXPANSION, TENNESSEE RELIES ON RYAN WHITE MORE THAN OTHER STATES.

Ryan White program clients living with HIV in Tennessee had no insurance coverage other than Ryan White in 2015.⁷

No other program provides the same set of gap-filling services or care as Ryan White. Even after health reform, Ryan White remains crucial for Tennessee.
